The funds have been used to provide our students and staff with the much needed technology that was lacking at home for many. We had to scramble to get the supplies found, ordered, delivered and set up so it could be provided to the staff and students in need. We have many teachers and paras here who needed help with technology since remote learning was not anticipated, therefore necessitating working through the kinks as they developed and were identified. The funds for the safe return in building were used for the cleaning, sanitizing, setting up of socially distanced classrooms and implementation of safe protocols as we returned to being around others after staying quarantined at home for many months.

We have been increasing services for our students that have suffered regression during the last school year due to the challenges of remote learning for our students with the most severe issues.

We have spent the full amount of the money allocated as well as more than what we received, since we were more concerned with the safe return of our students and staff than of the expense.
